

School Referral Promotion Terms and Conditions

Definitions

In this promotion the following definitions apply:

Referred Family means a parent or guardian that has been referred from a Participating School to a Participating Centre that has not previously held an account with the Participating Centre or enrolled a child in any Guardian centre previously.

Participating School means the name of the school who introduced the Referred Family to Participating Centre(s)

Participating Centre(s) means the name of the Guardian Centre(s) to which the Participating School introduces the Referred Family. Only corresponding Guardian centres as specified on this page

Enrolment Conditions means a new enrolment at a Participating Centre:

- a. has a start date specified by the Participating Centre within the Promotional Period.
- b. is for a minimum of two (2)-full days of care per week; and
- c. is for a minimum enrolment period of six (6) consecutive weeks.

Promotional Period means a specific period of time within which the Participating School introduces the Referred family to the corresponding Participating Centre(s) and the Referred Family commences their enrolment. Donation means a payment of \$100 AUD for each Eligible Referred Family to the Participating School.

Terms and Conditions

Eligibility and referral conditions	<p>To be eligible to participate in this promotion:</p> <ol style="list-style-type: none"> 1. The Referred Family must take a tour of the Participating Centre and provide the details of the Referring School to the centre manager or team member conducting the tour at the time of the tour; and 2. the Referred Family must subsequently enrol and start care of their child / children at that Participating Centre within the Promotional Period and otherwise satisfy the Enrolment Conditions. <p>Employees and relatives of Guardian are excluded from participating in the promotion.</p>
Collection of Donation	<p>6 weeks after a child (or children) of the Referred Family has commenced enrolment at a Participating Centre, and Guardian has otherwise verified that the Referred Family has satisfied the Enrolment conditions, Guardian will notify the Referring School by email if they are eligible for their \$100 donation for each eligible Referred Family and payment will be made to the Participating School via Electronic Funds Transfer.</p>
Supplementary to enrolment terms	<p>The terms and conditions of this promotion are supplementary to Guardian's enrolment terms and conditions which apply in full at all times. All bond and fee payments must be paid up to date by the Referred Family to participate in this promotion.</p>
Other matters	<ol style="list-style-type: none"> 1. Participating in this Promotion is deemed acceptance of these terms and conditions. 2. This offer under this promotion is not valid in conjunction with any other offer or promotion. 3. The \$100 AUD donation is offered to the Participating School only with a limit of one (1) donation for each Referred Family that satisfies the Enrolment Conditions. 4. Enrolments at a Participating Centre are subject to availability of care. 5. The Donation is not transferrable or exchangeable. 6. Guardian reserves the right to amend or withdraw this promotion at any time in its absolute discretion without notice but will honour any donations to Participating Schools that are eligible at the time the promotion is amended or withdrawn. 7.
